From Our Co-op Board President:

Fellow DFC Member-Owners and Supporters:

I'm honored for the opportunity to share my gratitude for the support and work of every one of you. I was not there at the beginning, but I know that right about this time, 10 years ago, neighbors were coming together around the need for a food co-op in Dorchester.

COVID has a way of blurring our sense of time. While some things slowed down, the DFC timeline didn't. Our Board doubled up on meetings to keep up with the work. Some became experts at zoom. Others of us continue to resist and can't wait for a level of normalcy to return so that we may again work in teams and in-person.

They say "we make the road by walking". I'd say we've made OUR ROAD by walking and knocking. And knocking. And knocking. We've knocked on so many doors! Many doors have opened, and some have not. But in organizing, we also say "there are no permanent friends, no permanent enemies, just permanent issues". And that's what keeps me going. Like our motto says: "Cooperation is our approach. Justice is our goal". Justice has to be our goal. That is why this work is so important. That is why this next year is so critical for our cooperative.

COVID made more than clear the role that access to nutritious food has on our physical health. In my own experience, it is also the basis for mental and spiritual health. Last fall, a few of us were able to set up a table in front of 195 Bowdoin St. and engaged neighbors with paper copies of the same design tools used in our zoom series. As they passed by to do their shopping, the conversation with neighbors always included "fresh veggies", freshly baked bread", "hot peppers", "dried chiles", and left us smiling. Food is medicine! For the mind, the body, and the soul.




2019-20 Financial Notes:

In FY '19-20 our Co-op added 243 new member-owner households over the two years, generating an additional \$19,900 in member equity. The total member-owner investment in the Co-op at the end of 2020 was \$77,416. In addition, we received \$66,011 in grants, donations, sales and interest over that two-year period.

In the coming year, both our income and expenses are growing, as we add staff, and expenses to prepare for store buildout.

Membership Growth

In the past two and a half years we have grown exponentially, and as of April 2021, we have gained 290 member-owners for a total of 969 household members. We are very close to our milestone of 1000 memberowners, and our goal is to reach 1200 member-owners before the end of 2021. Together we can do this!



VALUES IN ACTION

The Dorchester Food Co-op has important values, and we as an organization are bringing these values to life. These values will be embedded in the operations of our new store, and inform the projects we develop before the store opens. In 2019-2020—**these are a few of the values we put into action**:

1 We believe that everyone should have

access to fresh local produce they deserve



In 2019-20, DFC created mini farm stands for vulnerable seniors in adult day programs in collaboration with **Upham's Corner Health Center and**

Boston Area Gleaners. The program enables seniors who are housebound and cannot get to farmers' markets to access fresh produce in a market-like setting. **In 2019-20 we delivered over 4500 lbs of fresh local produce to seniors** in Dorchester, Roxbury and Jamaica Plain.

2 We believe that supporting local farmers and food entrepreneurs is essential for the economy and the environment

In 2019, we started a "hyper-local" Community Supported Agriculture program. CSA's offer a box of seasonable vegetables to subscribers at a set rate. CSA's benefit local farms by providing a fixed income

steam at the beginning of the season. And consumers benefit by having a wide range of local produce available weekly. The "hyper-local" CSA was developed in collaboration



with OASIS on Ballou Farm in Dorchester and Urban Farming Institute in Mattapan, both BIPOC operated non-profit farms. In 2020 we continued to provide important revenue to these urban farms and created subsidized "solidarity" shares to those in need.

3 We believe in building an asset that is truly of, by and for the people

In 2020, after a national search, we hired CoEverything, a local BIPOC led design firm that specializes in cooperative development and community informed design. CoEverything led a summer interactive design series and survey that engaged more than 200 DFC members to help design the new store. The results of this community input have been incorporated in the final store design, "of, by and for the people."



"We have an opportunity to really, more profoundly, embrace and engage the community in something that matters. And food matters! Member Engagement

Member engagement was strong in 2019-20. Dozens of members spread the word about the Co-op at Farmers' Markets and Community Events (including Juneteenth celebration at Franklin Park, Dorchester Bike and Brew in Peabody Square, tabling in Bowdoin Geneva and neighborhood and block club meetings) Other activities included work days at **OASIS on Ballou Farm** in Dorchester, and a "**Green Future Fest**", a festival to highlight climate change work in communities of color. (in partnership with the **Trustees, Resonant Energy, Boston Cyclist Union and Co-op Power**)

The Pandemic shut down many of these activities in March of 2020, and the Co-op learned to Zoom and pivot to on-line activities. In the fall of 2020 we had a film screening and discussion on the history of food co-ops. Monthly Meet & Greets were established, and Co-op membership accelerated.

Building our Co-op has begun!

Construction began in late January 2021 for the building that will house the Dorchester Food Co-op and 41 units of affordable housing
